Our Mission:

Market Guidelines:

It is the intention of Millington Farmers Market to provide a pleasant, clean and orderly environment filled with a variety of fresh agricultural products. Therefore:

- ^ Millington Farmers Market has complete decision making authority on which vendors participate at the market. Please know that no vendor will ever be denied participation for reasons regarding race, gender or religion.
- ^ Vendors are expected to conduct themselves in a pleasant and courteous manner at all times. No loud shouting, profanity, loud radios or music or any disparaging action will be permitted.
- ^ Vendors will set their own prices in keeping with appropriate customer satisfaction and consideration of fellow vendors.
- ^ Millington Farmers Market is open rain or shine.
- ^ Vendors will be allowed to set up 1 hour prior to opening and have one hour after closing to break down and clean their assigned area. All set up and break down must take place outside of normal operating hours. If a vendor is not present at the time the market opens for business, it will be assumed the vendor is forfeiting their fee for that day. Millington Farmers Market reserves the right to rent that space to another vendor.
- ^ If a Full Season Vendor will not be able to participate on a given day, notify Lonnie Nunn, Market Manager at 901.849.1998 48 hours in advance so that space may be utilized by another local grower.
- ^ Millington Farmers Market will provide a 10' x 10' space with electricity for each vendor. The vendor will provide any tables, chairs or other display fixtures needed to display their product in an aesthetically pleasing manner. Tables need to be covered. No products will be displayed on the ground.
- ^ For health reasons, no animals are allowed on the market grounds with the exception of service animals. However, live animals can be advertised at individual booths for off-site sales.
- ^ 100% of the products sold must be locally grown within a 200 mile radius of the market. 90% must be from the grower's own farm. Up to 10% can be from another local farm. No resale of commercially, mass produced items of any kind allowed.
- ^ Vendors with products from a distance greater than a 200 mile radius will be considered on a case by case basis as long as the product does not compete with the same or similar product of a local farmer.
- ^ It is the sole responsibility of the each vendor to comply with all applicable laws and regulations, obtain all licenses and pay all fees required by applicable laws and regulations. The collection and filing of all related taxes are the responsibility of the individual vendor. For further tax information, please consult a tax professional.
- ^ Vendors will assist in ensuring the market is safe and accessible for all customers including those with disabilities.
- ^ The last Saturday of each month Arts and Crafts Vendors will be allowed to set up a 12'x12' tent outside the pavilion and sell HANDMADE arts and crafts.
- ^ Failure to comply with market procedures or to make payment of fees on time will be considered just cause to immediately cancel arrangements.
- ^ Millington Farmers Market will have a Market Manager on duty whenever vendors are present. All questions and concerns including those with other vendors will be handled by the Market Manager.

How to participate...
